Collection Statement – Patients

The Everyday Support Program is a complimentary service provided by UCB Australia Pty Ltd (ABN 48 005 799 208) of Level 1, 1155 Malvern Road, Malvern VIC 3144 ('UCB'). The program provides support for patients who have been prescribed Cimzia® (certolizumab pegol). If you would like to participate, please take a few moments to read this statement.

By completing the form, you agree to its terms. The Everyday Support Program is made up of an injection training program and an educational and emotional support program. The Everyday Support Program is administered by Sonic Nurse Connect (ACN 095 610 478) of 14 Griffnock Avenue, Macquarie Park, NSW 2113 ('Sonic Nurse Connect'), and the web portal is hosted and administered by Zentir Pty Ltd ('Zentir') (ACN 138 115 054), Suite 2, 1-7 Probert Street Camperdown NSW 2050, Australia, on behalf of the sponsor, UCB. Sonic Nurse Connect and Zentir are the organisations that collect and process your information including health and sensitive information ('Personal Information') required for your participation in the program. If you agree to participate in the program, Sonic Nurse Connect and Zentir will collect further Personal Information from you during the course of the program. The Personal Information collected will include: your and/or your carer's contact details, your doctor, your preferred appointment venue, your relevant medical history, competency with injection technique and process, as well as other Personal Information necessary for the program. If you do not wish to provide your Personal Information as described, you will not be able to participate in the program. Your Personal Information may be shared with your treating physician or carer.

Anonymised population level data, meaning information not disclosing your identity, may be shared with authorised third parties for program evaluation and the improvement of the service. In case of an adverse event being reported whilst enrolled in the program, Sonic Nurse Connect are legally obliged to pass on to UCB, as the sponsor of Cimzia®, details of any adverse events involving its products that they become aware of. Only de-identified data, meaning data not disclosing your identity, will be provided to and used for this purpose by UCB. UCB or an authorised third party may contact your healthcare professionals for the purpose of adverse event follow-up.

Your Personal Information will be held by Sonic Nurse Connect and Zentir on a database within Australia, and it will be held for 7 years from the end of the program.

Collection Statement – Prescribers

The Everyday Support Program is a complimentary service provided by UCB Australia Pty Ltd (ABN 48 005 799 208) of Level 1, 1155 Malvern Road, Malvern VIC 3144 ('UCB'). The program provides support for patients who have been prescribed Cimzia® (certolizumab pegol). The intention of this program is to help patients understand their condition better, use their medicines correctly and align to the principles of the National Medicines Policy. For example, if enrolled in the program, your patient will receive disease-specific information and support from registered nurses. The program is only ever offered after patients have been prescribed Cimzia®. You can enrol patients into the program by fax or they can self-enrol into the program via the telephone. UCB or an authorised third party may contact you if an adverse event is reported in relation to your patient as part of the program.
